

# MOSQUITO FREE™ Insecticide

**PURPOSE STATEMENT:** Mosquito Free™ can be used year round (southern states). Does not cause discoloration. Not for use on edible crops.

**TRUCK TANKS:** Fill tank half with water then add product to avoid foaming, then add remaining water. Use entire bottle to make 300 gal. or 12 oz. per 100 gal. Use no more than 100 psi to avoid drift. 25-40 gal. of RTU per acre depending on saturation. See section below for further instructions.

**MIST BLOWERS/3 GALLON BACKPACK SPRAYERS:** Add 1 oz. to make 3 gal. Shake well. This bottle will make 108 gallons of RTU product when spraying with this method.

**DIRECTIONS FOR USE:** Spray under shrubs, wood piles, leafy, shady or moist areas. Spray into trees up and under leaves. For best results, spray every 21-30 days. If infestation is severe, spray 15 days after the first infestation then resume normal schedule.

**Do not dilute more than recommended.** You can use

more product per gallon for heavily infested areas at a maximum rate of 1 oz per ready to use gallon. Once area is controlled resume to 1 oz per 3 gal. of ready to use. This rate is for mist blowers only. Allow up to 1 hour or more for drying time depending on humidity. Dispose empty container according to your state's requirements for non-hazardous materials. Product is hazardous to aquatic life. Do not spray or pour into any body of water. Do not spray around active honey bee hives. Do not apply this product while pollinators are actively foraging in the treatment area. Store in a cool, dry location away from sunlight.

*Intended use is to target adult mosquitos. Use regularly for best results. This product is not registered with US EPA. LESCO, Inc. represents that this product qualifies for 25b exemption under FIFRA.*
